BRITISH AND IRISH GOVERNMENT DOCUMENTS

The heading for Great Britain is the largest and most complex within the ESTC. Arranging the heading is made all the more difficult by the lack of fixed names for the various subdivisions, by the ambiguous nature of much of the printed matter, by the frequent lack of clear statements of responsibility, by the absence of official short titles for legislation, and, perhaps most importantly, by the lack of resources in time and personnel to acquire the detailed historical understanding of the material necessary to arrange the entries in a manner that is at once accessible and correct.

To make cataloguing and arranging the material as straightforward as possible, the following principles have been adopted for cataloguing all material entered at "England", "England and Wales", "Great Britain", "Ireland", and "Scotland", and their subdivisions, which are contrary to those of AACR2.

- 1. All works emanating from or primarily recording the activities of the British government or government bodies, whether officially published or not, are entered under Great Britain, or Ireland, Scotland, as appropriate.
- 2. All items within a subheading or subdivision of Great Britain, etc. are arranged in a hierarchical or chronological order, unless their number is so small as to make such arrangement unnecessary.

ENGLAND, ENGLAND AND WALES, AND GREAT BRITAIN

Wales was incorporated into England in 1536 (28 Hen.VIII.c.3). Prior to this date, the heading for English official material should be "England"; official material issued in 1536 or after and before 1707 should have the heading "England and Wales".

Collections of items issued both before and after 1536 should have the heading "England and Wales".

The two independent nations of Scotland and England and Wales were united in a legislative union on 1 May 1707 (6 Anne c.11; the Scottish act 1706 c.7). After this date, both nations ceased to exist as separate entities, being subsumed within the new nation of Great Britain. For all items appearing after this date, other than those which are simple reprints of earlier items, the heading is "Great Britain".

The year 1707 poses a problem. For convenience of cataloguing, all items appearing in this year will be entered at "Great Britain", unless the item can be precisely (and readily) dated before 1 May.

For collections of items which appeared both before and after 1707, use the heading "Great Britain".

In the rules below read "England" or "England and Wales" for "Great Britain" as appropriate.

ACTS OF PARLIAMENT AND OTHER LAWS

Treat as acts only those publications which are clearly printed after enactment.
All other publications entitled 'An act . . .' should be treated as bills.

Enter all acts at: "110.1 \$aGreat Britain".

Give a collection of acts which is complete for a chronological period, whether for the whole period from Magna Charta, or for a limited period only, or for a single year, a uniform title in the form:

Give a selection of acts on a specific subject a uniform title in the form:

Note that the subject element should not exceed two or three words, and should in general be taken from the item itself.

Give a single act a uniform title naming the kind of act ("Public General", "Private", "Local"), the year of enactment, the regnal year and chapter number.

If the titlepage of a single act or a collection does not give the title proper, but only a form of words indicating the fact and year of enactment, make a note of the drop-head title on the first page of text, or give a note of the subject or chronological coverage.

If two or three acts are found together, enter under the uniform title appropriate to the first.

Give other laws created before the existence of Parliament the heading and uniform title:

TREATIES

Enter treaties according the general rules for entry. If a collection of treaties entered under title has Great Britain as one of the signatories, make an addeed entry under Great Britain. Give treaties a uniform title (or added-entry uniform title) according to the rules given for MARC tag 240.

Use this uniform title with any documents which are clearly official, but for which no other subheading or uniform title can be found.

Add the most specific date which can readily be found for the original publication or issue of the item.

BILLS

Treat as bills all printed "bills" or "acts" which are not clearly published after enactment. Transcribe in MARC tag 245 the drop-head title, if there is no titlepage (as in the vast majority of bills); make a note of the docket title if the first five words are different.

Enter all bills at "110.1 \$aGreat Britain\$cParliament", irrespective of whether a specific bill may be assignable to a particular House.

Give all bills a uniform title in the form:

240.10 SaBills. [date of first reading yyyy-mm-dd]

Note that the date of first reading is that of the earliest reading in either House, not necessarily the date of reading the specific text being described.

Make notes on the official numbering of the act(s) as passed, or to the effect that it was not enacted; on the presence of a docket title; on the fact that the title is taken from the drop-head title.

PARLIAMENTARY PAPERS

Items entered under one or other of the Houses of Parliament fall into three categories: "proceedings", "Votes" or "Lists".

Treat as proceedings all records of parliamentary debates, all documents which were ordered to be printed by a vote of the relevant House; all records of impeachments, etc. heard before the House of Commons.

Give all such proceedings the main entry:

Add a uniform title in the form:

The date should be the date of the actual proceeding or, in the case of papers "ordered to be printed", the date of the order. Give a note clarifying the nature of the item and, if necessary, the date. If the date cannot be established exactly, give the month or, if necessary, the year only.

If the body or person preparing the item is different and his or its name can be readily determined, give this person or body an added entry. Do not, however, treat a committee of either House as a separate subordinate body.
